

English version of attached Gujarati version notice of Ahmedabad Education Society

All members of the Society are hereby informed that

1. The final Electoral Roll of the members/voters of AES with all necessary addition and correction has been placed on the notice board of the Society on 29th April, 2022 and same shall be considered to be final for the elections.

2. As per the constitution of our Society, elections will be held for the following posts.
 - (1) Three Trustees will be elected.
 - (2) Eight members will be elected in the Governing Body mentioned here in below :
 - (a) Three Life Members of the Society will be elected as members of the Governing Body.
 - (b) One educationalist will be elected as a member of the Governing Body.
 - (c) The remaining four members of the Governing Body will be elected from Non-Life Members of the Society.
 - (3) Members will be elected in Council as mentioned here in below :
 - (a) Five Life Members of the Society will be elected as the members of the Council.
 - (b) From among the Patron, Vice-patron and Donor Members, three members will be elected.
 - (c) Eleven members will be elected from among Non Life Members of the Society.

3. Any member who would like to contest the elections for any position as mentioned here in above, can collect the candidature form from the Society's office on any working day between 12.00 noon to 5.00 p.m. after 9th May, 2022. Duly filled in candidature forms required to be submitted to the Society's office on any working day between 12.00 noon to 5.00 p.m. latest by 19th May, 2022. Any forms received after this deadline will not be considered for Election. All persons filling the candidature form shall submit photocopy of any identification proof as mentioned in clause 9 of this notice that may include Photocopy of the Aadhar Card or election card, or Photo Pan Card or Driving License or Passport.

4. All candidature forms alongwith necessary supporting documents received upto 5.00 p.m. on 19th May, 2022 will be scrutinized on the same day at 5.30 p.m. by the

President of the AES. Any candidates and their proposers and seconders (supporters) can remain present at the time of scrutiny of candidature forms of such candidates, their proposers and/or seconders (supporters) will be allowed to submit clarification against those forms which the President consider for rejection. After considering such clarification the President will take the final decision. In accordance with the President's decision the details of the rejected candidature form(s) will be placed on the notice board of the society on the next day.

5. Any candidate can withdraw his/her candidature form upto 27th May, 2022. The final list of candidates will be announced on the notice board at 5.30 p.m. on 27th May, 2022.
6. The date of Election has been fixed on 12th June, 2022 and on the same day Election will be held during 10.00 a.m. to 5.00 p.m. through vote by ballot.
7. The Polling centre (Venue for election) will be fixed at The Ahmedabad Education Society Office Premises, Near Commerce Six Road, Navrangpura, Ahmedabad.
8. The President of the Society shall appoint two members from among the members of the Society as Scrutineers, for the election process.
- 9.(a) Any Individual Member who comes to cast his/her vote is required to bring along photocopy of his/her Aadhar Card, or election card, or photo pan card or driving license or passport for the purpose of establishing his/her identity.
- (b) Any person representing a partnership firm and comes to cast his/her vote on behalf of such partnership firm is required to submit the resolution of all partners of the firm, his/her nomination as the representative and to cast vote or copy of the power of attorney alongwith the photocopy of the identity proofs as mentioned in clause 9(a) herein above.
- (c) Any person representing an association and comes to cast his/her vote on behalf of such associated is required to submit the authority letter/resolution as well as identity proof as mentioned in clause 9(a) herein above.
- (d) Any person representing a Company and comes to cast his/her vote on behalf of such Company is required to submit the authority letter/resolution as well as identity proof as mentioned in clause 9(a) herein above.

- (e) Any person representing a Trust and comes to cast his/her vote on behalf of such Trust is required to submit the authority letter/resolution as well as identity proof as mentioned in clause 9(a) herein above.
- 10.(a) The ballot counting will commence immediately after the completion of the election time and will continue uninterrupted until completion without break.
- (b) Candidate can remain present during the process of counting.
11. Election of President & Vice President
- 11.(1) The Final Electoral Roll placed on 29th May, 2022 at the Notice Board of the Society with addition and correction shall be considered as final for the Election of President and Vice-President.
- 11.(2) The date for Presidential and Vice-Presidential elections will be fixed on 12th June, 2022 and on the same day Election will be held during 10.00 a.m. to 5.00 p.m. through vote by ballot.
- 11.(3) Those members who would like to contest for the Presidential and Vice-Presidential posts will have to procure the Candidature form for the same on any working day between 12.00 noon and 5.00 p.m. after 9th May, 2022, from the AES office. All such candidates will submit duly filled in forms during any working day, between 12.00 noon and 5.00 p.m., latest by 19th May, 2022. No such forms will be considered after 5.00 p.m. on 19th May, 2022. All candidates filling up the candidature form will have to submit photocopy of identity proof such as Aadhar Card or election card or photo pan card or driving license or pass port.
- 11.(4) All candidature forms alongwith necessary supporting documents received upto 5.00 p.m. on 19th May, 2022 will be scrutinized on the same day at 5.30 p.m. by the President of the AES. Any candidates and their proposers and seconders (supporters) can remain present the time of scrutiny of candidature forms of such candidates, their proposers and/or seconders (supporters) will be allowed to submit clarification against those forms which the President consider for rejection. After considering such clarification the President will take the final decision. In accordance with the President's decision the details of the rejected candidature form(s) will be placed on the notice board of the society on the next day.

- 11.(5) Any candidate can withdraw his/her candidature form upto 27th May, 2022. The final list of candidates will be announced on the notice board at 5.30 p.m. on 27th May, 2022.
- 11.(6) The polling centre will be at the office premises of Ahmedabad Education Society located near Commerce Six Road, Navrangpura, Ahmedabad.
- 11.(7) The President of the Society shall appoint two members from among the members of the Society as Scrutineers, for the election process.
- 11.(8) The members residing at Mumbai, if willing to vote for the Election of President and Vice-President's posts in person during the General Body Meeting, they will submit documents as per clause (9) above and will also be allowed to vote in person at Ahmedabad for the election of Trustees, Governing Body and the Council members.
- 11.(9) The members will have to submit identity proofs as mentioned in clause (9) of this notice herein above.
- 11.(10) The ballot counting will commence immediately after the completion of the election time and will continue uninterrupted until completion without break.
- 11.(11) Candidate can remain present during the process of counting.
- 11.(12) Special General Body meeting of Ahmedabad Education Society will be held on 12th June, 2022 at the Society's Office campus. Declaration of results of the Society's President, Vice-President and all other posts mentioned above will be the agenda for the meeting.
12. The timings for the Special General Body Meeting will commence at 9.30 p.m. onwards and will continue till all the results are declared. It will be a mandatory for the member to submit identity proofs as mentioned in clause (9) herein above for attending such meeting.
13. Election results will be displayed on The Society's notice board and the candidates will also be informed about the same.
